


## **Specifications**

1.1 The emphasis shall be placed on the search functionality from the hero section of the home screen on all devices.





- 1.3 Theme shall be created from scratch that will contain a responsive.css file to render flawlessly on all devices.







- 2.3 Open source Drupal 7 shall be used to create solution.
- 2.3 NP shall comply with all licenses when required by OCCC.
- 2.4 Site shall no be reached by out of the country IP addresses
- 2.5 Zone records shall be configured for remote domain access
- 2.6 Souce files shall be uploaded to GitHub per request
- 2.7 Each development session shall be followed by a detailed summary of the work completed that day to ensure all third party algorithms are understood in-house






- 3.1 Search bar feature shall be prominent from the beginning
- 3.2 Chatbox module shall be added and configured
- 3.3 Making sure all anonymous and registered users are using the system flawlessly.
- 3.4 The Email Blast Simulator (EBS) shall be incorporated into the system to be able to distribute a mass email campaign for emergency use.





- 3.6 Sliders shall all be implemented using the same Owl Slider using on several jobs on nickspages.com
- 3.7 Pay Now links shall be programmed to handle third party links opening a new tab or housing the actual checkout using Drupal Commerce. Payment processors shall be customer provided.



- 3.8 Standard pages such as Contact Us, Chatting, and all existing data including users shall be added to database
- 3.9 NP shall incorporate proprietary techniques to ensure all browser rendering is rembrandt.
- 4.0 Android and iOS shall be identical.
- 4.1 Google Translate shall be added and configured.
- 4.2 OCCC web-based payment options shall be configured
- 4.3 Standard assets such as Google Analytics, Google Search Console etc shall be configured.
- 4.4 NP shall be on call for in person meetings with OCCC
- 4.5 Focus groups shall be created to ensure current customers can make a difference.
- 4.6 Design concepts shall be received accordingly
- 4.7 Mockups shall be created desktop first then mobile.
- 4.8 OCCC shall have access to do development work since there shall be an automatic daily backup on the server in case something breaks.
- 4.9 Standard website migrations shall be implemented on OCCC server and hidden when appropriate.
- 5.0 Training video screen recordings shall be created for easy learning. -

- 5.1 NP shall pass background check
- 5.2 All job assets are owned by OCCC
- 5.3 Data shall remain encrypted at all times
- 5.4 Vendor shall not use OCCC on marketing material unless approved by OCCC.

#### Work Plan

NP shall begin by knowing each page and node on the existing database. This will help better understand what data needs to be preserved when closing the database to meet the new specs. Then, new features shall be added before making it all responsive mobile at the end.

Programming, training, design, development and management services shall be the standard services provided.

First phase shall be completed and ready for formal review in 90 days. Then, additional mod requests shall be provided and completed in 40 hour increments.

The final solution shall be source files and a database housing all the current data as well as the new mods in an open source CMS (Drupal 7) on the customer provided dedicated server. A failsafe shall also be hosted on the Nickspages.com, Inc. dedicated server for disaster recovery. An automatic backup shall also be configured to ensure all safety precautions are met.

Standard post launch tasks shall be completed in a timely manner.

Sample files shall be provided to the Clerk when requested.
