Nickspages recommends using Drupal as the CMS due to experience. We can project which CMS is better for any set of specifications due to our experience using 50% Drupal and 50% WordPress for our clients.

We are used to creating super complex algorithms in Drupal and we know it is best to deliver the site in 60-90 days in Drupal. We can do all specifications in the RFP in 40 hours flat if we had to. 40 hours would include a custom responsive theme without framework and custom post of content types for all. We can do this and project cost accurately due to experience.

Proposed Solution

Nickspages shall create a custom responsive theme without framework using the content management system called Drupal. We shall then add and configure php packets called Modules which will add the majority of the functionality needed from Section IV of the RFP.

The CMS shall then use a custom and proprietary theme without framework. This shall hold all of the custom CSS that shall be needed to hold design requirements. All of our custom responsive themes without framework look perfect on all mobile devices such as iPads, Androids, and iPhones.

The site shall then pass a rigorous QC phase which will not only pass all of the requirements by the Knox County staff but also all the devices in the Jupiter, FL office.
